Mary Beth Hughes representing the San Diego Sockers followed with a reminder of the special events the Sockers have planned for the 2017 – 2018 season. Dike Anyiwo representing SoccerNation spoke as did Kerry Taylor representing Soccer City.

**Approve Agenda:** A motion to approve the agenda was made by 1<sup>st</sup> Steve Marx with a 2<sup>nd</sup> provided by Silvestre Vigilante. The motion was approved by unanimous consent.

<u>Cal South District Commissioners - Board Members:</u> Derek Barraza (President), Mark Flahan (District 1 Commissioner) and Luca Pacelli (District 2 Commissioner.

Derek reported the Woman's Leadership group is trying to increase the number of women coaches at all levels.

There will be new licenses for 7v7 and 9v9 coaches at the beginning of 2018. An "E" will be recognized for a few years, but will phase out. A club representative asked that higher level License classes for "C', "B" and "A" levels be made available in San Diego.

The Cal South "Concussion Protocol" will be published in the next 24 – 48 hours.

Cal South and US Soccer elections will held in the next few months. A local club noted they recently received a statement from Cal South imposing a \$1,000.00 fine on the club for an event that occurred months earlier at State Cup by a coach that was no longer with the club. The club was encouraged to file an appeal to explain the circumstances.

Derek informed Presidio membership the FIFA and US Soccer of near future rule enforcement on players and coaches to prove citizenship, country and date of birth and license beginning in 2018.

Cal South is looking at another vendor to bid on support and management of the CORIS system.

### **Board Reports:**

<u>Secretary:</u> The minutes for the August  $15^{th}$ , 2017 Presidio General meeting, as posted on the website, were presented for approval. A motion to approve the minutes was made by  $1^{st}$  Steve Marx with a  $2^{nd}$  provided by Silvestre Vigilante. The minutes were approved by unanimous consent.

<u>Treasurer:</u> Reminder to clubs that have used same day reschedule owe Presidio a \$50.00 fee.

<u>Vice President:</u> A reminder to team managers to enter a "suspected head injury" on game report and hold the player card to make sure player does not return to play until a proper written medical clearance is received.

<u>Director SDDA Boys:</u> Kathy reported only 25% of game reports are being received.

<u>Director AAA & SDDA Girls:</u> Presidio is not getting the game reports from managers and referee reports from the referees. This causes a delay in adjudicating the results of the game if Red/Yellow cards have been issued. Reminder, the Presidio Directors cannot reverse the issuance of a Red/Yellow card.

<u>Director North:</u> Christine commented she has seen 5 Red Cards on coaches/managers already this year. She reminded team coaches/managers that Jersey Numbers need to be entered on the game report.

**Director South:** No report.

<u>Assistant Director North:</u> Bj reminded the membership the "rescheduling period" is over and to refer to the 2017 Presidio Administration Guide for rescheduling information.

<u>Assistant Director South:</u> Tim endorsed Bj's comments.

Game numbers are needed on all correspondence to Presidio (email, fax, letter, etc). Some coaches are still trying to use "F" licenses to coach a competitive game. Team managers are not asking for referee ID cards to confirm the name of the referee on the game report.
